- **Regular attendance at all rehearsals.** If unable to attend, I will notify PMAA by leaving a message at (650) 268-8345 prior to rehearsal. **I understand that if I miss three rehearsals I may not be able to participate in the season’s performances, at the musical director’s discretion.**
- **Attendance at scheduled technical rehearsals and seasonal performances.** I understand that failure to attend the technical rehearsals will mean I may not participate in the season’s performances. (Special circumstances will be considered at the musical director’s discretion.)
- **Memorization of performance music** as directed by musical director.
- **Purchase of performance costume** as agreed by musical director and program committee.
- **Proper care of music and return of same at the end of season.** I understand that the cost of lost, damaged, or non-returned music may be billed to me. **All markings on music will be made in pencil.**
- **Participation fee:** Full amount payable to PMAA at time of registration or no later than the third rehearsal. I understand that there will be no refund after that date. **Registration fee is \$115** per season for Foster City Community Chorus.
- **Responsibility to encourage community attendance at season concert** through publicity and ticket sales.

### Hold Harmless Clause:

- To the extent allowed by law, I hereby absolve the Peninsula Musical Arts Association, the City of Foster City, the Estero Municipal Improvement District, their officers, employees, agents, independent contractors, and program and activity instructors from all liability that may arise as a result of my participation in activities that I or any member of my family attends.
